The name "Spunky" seemed to fit him. His motto could be "You pet; I purr". He loves attention and is a very special boy.


If you see a cat in your future come meet Spunky. You will fall in love.

Where Does all the Money Go?



The amazing fact is, in 2020, we were able to maintain our No-Kill shelter and place over 100 fully vaccinated and neutered cats and kittens in adoptive homes for less than \$30,000 dollars.

Of course, we are an all-volunteer organization, so we have no payroll, no CEO's salary. Virtually all the food for the kitties is donated by Nestle PURINA and private donations, and all the litter is donated by Dr. Elsey's.

The founding committee was able to pay off the mortgage on the shelter in 2015 and as a 501- c3 we don't pay property tax, so we're rent free. Gas, light, water and phone, etc. absorb about 18% of the budget. And, as many of our placements go through PETSMART locations in Sterling, IL or in Davenport, lowa, the volunteer who drives them is reimbursed for mileage (Transportation of Cats).

Our largest single expense is for veterinary services and medicines, 57% of the total. And, even here, our primary veterinarians at Mount Carroll Veterinary Clinic, give us a 30% discount on services.

So, as a donor, you may rest assured that not a penny is wasted and every dollar is spent on the kitties.
